

## SPANISH COURSE DETAILS

- 1 lesson = 55 minutes.
- Registration fee: 45 €. Applicable in all courses except for private lessons. Includes placement test, learning material, bag, promotional info and final certificate.
- All our group courses are weekly -from Monday to Friday- and start every Monday at 10 AM.
- Group is formed with a minimum of 2 students. If the student is the only person of that level, he/she will have half of the lessons booked in a private lessons format.
- Extra week is applicable after 4 weeks.
- Residential course is only available for residents in Malaga and not for beginners.
- Summer Family Course is only available during the International Summer Camp. Prices include one adult (Intensive Spanish Course) and one child/teenager (International Summer Camp -Day or Full Day Camp-).
- Private lesson schedule is fit to the student's needs. Registration fee and learning material are included. Cancellations should be made 24 hours before the lesson, otherwise the lesson is considered completed and it is charged.

## ACCOMMODATION DETAILS

- The prices are in Euros (€) per person, VAT included.
- The CENTER only provides accommodation for the STUDENT and during the course period (with the possibility of up to 4 extra night).
- If, under special circumstances, the CENTER decides to offer accommodation to people not enrolled in a language course, these individuals must pay an additional fee to be decided by the CENTER.
- Towels and bed linens are provided in all accommodation options.
- Double rooms are only available for STUDENTS who book together.
- In high season (Easter, and from June 1 to September 30), a 10€ additional fee per night and person is applied to all accommodation options.

#### 1. Accommodation with a Spanish family.

- Available for students from 12 years onwards.
- Families have a binding contract with the CENTER and meet the legal requirements for hosting.
- The CENTER ensures the student's comfort through regular inspections of the accommodations.
- The STUDENT can choose between the options of breakfast only, half board (breakfast and one meal, lunch or dinner), or full board (breakfast, lunch, and
- Check-in time is from 4 p.m. If the STUDENT cannot meet this time, they must notify the school or the family of the arrival time in writing.
- There is a supplement of 35€ per person and week for dietary restrictions in family accommodation.
- Any changes in the type of accommodation must be made through the CENTER, never directly with the families.
- Family changes are only considered under special circumstances, at the discretion of the CENTER, and only if there are families available.

#### 2. Accommodation in an apartment.

- Available for students from 17 years old onwards.
- To secure the apartment, the STUDENT must pay 25% as a reservation fee, in addition to a security deposit amount that will vary depending on the total price of the contracted accommodation. The remaining 75% of the total price is due no later than the first day of the course.
- Check-in time is from the Sunday before the course starts at 2 p.m., until the Saturday after the course ends, at 11 a.m. If the STUDENT cannot adhere to this schedule, they must inform the CENTER in advance and in writing.
- The STUDENT will receive the deposit back within a maximum of two weeks after the course ends, provided no damage has occurred in the apartment. Part or all of the deposit may be withheld if:
  - The STUDENT has caused damage to the furniture or facilities.
  - The STUDENT has not returned the keys.
  - The apartment is not returned in a clean and orderly condition.





- The STUDENT will be charged for the replacement of any item broken due to negligence or misuse.
- The apartment price includes reasonable use of water, gas, and electricity. Excessive use of these supplies will be paid for by the STUDENT according to the consumption made. Parties in the apartment are prohibited and may result in expulsion from the apartment without the right to a refund.
- The CENTER reserves the right to change the STUDENT's apartment at any time.

## PAYMENT DETAILS

- All payments must be made according to the invoice, which has been sent to the student, in EUROS (€).
- 25% of the total price stated on the proforma invoice must be paid in advance at the time of course reservation, within 14 days of the proforma invoice date unless another agreement has been made between the STUDENT and the CENTER (e.g., last-minute registrations). The remaining 75% of the total price is due no later than the first day of the course.

# CANCELLATIONS | WITHDRAWALS LATE ARRIVALS | NON-ATTENDANCE

#### 1. Course.

- If the STUDENT cannot attend classes for reasons not attributable to the CENTER, the STUDENT is not entitled to any compensation from the CENTER, and missed classes cannot be rescheduled.
- If a class cannot be conducted due to reasons attributable to the CENTER, the class will be rescheduled according to an agreement between the CENTER and the STUDENT, either at the time of cancellation or later, as per the student's preference, and confirmed via email.
- Cancellations must be made in writing.
- For cancellations made more than 30 days before the course start date, the amount paid, except for the registration fee, will be refunded.
- For cancellations made between 15 and 30 days before the course start date, 50% of the amount paid, except for the registration fee, will be refunded.
- For cancellations made less than 15 days before the course start date, no refunds will be issued.
- In case of withdrawal, delayed arrival, or failure to attend the course, no refunds will be issued except in special cases. In such circumstances, the CENTER will decide if a refund is warranted.
- The CENTER reserves the right to ask the STUDENT to leave the school for severe misconduct. In such cases, no refund will be issued.
- If the student is the only one at their level, the STUDENT will receive half of the booked hours in a private format, as long as this situation persists. The student will be informed of this possibility in advance.
- If the school must cancel the services contracted by the student due to unforeseen circumstances, the school will refund the total amount to the student. The course can be postponed if the student wishes; in this case, no refund will be issued.

#### 2. Accommomdation.

In case of cancellation more than one month prior to the arrival date, the CENTER will refund all payments made in advance. In case of cancellation less than one





month prior to arrival, the STUDENT will pay for any reservations made for the following 30 days.

- If the STUDENT decides to postpone or temporarily interrupt their course, the accommodation cannot be canceled under any circumstances.
- The CENTER reserves the right to cancel the student's place if, on the arrival day, the student or the agency has not fully paid for the course, accommodation, and other contracted services.
- In case of disciplinary offenses, inappropriate behavior (such as disrespect towards the teacher, classmates, and other staff), or violation of Spanish law, the STUDENT will be expelled from the school and the accommodation contracted with the CENTER, without the right to a refund.

## STUDENT VISA

The CENTER complies with the legal requirements for conducting Spanish courses that are the subject of an authorization for a study stay.

#### 1. Invitation Letter.

- In the event that the STUDENT needs a visa to enter Spain, the CENTER can send an invitation letter as proof of enrollment in the course. The following conditions must be met:
- The STUDENT must enroll in an intensive course of 20 classroom hours per week in an in-person format. This course is not transferable to any other course
- The STUDENT must make the full payment for the course (100%) and for the accommodation reservation if this service is requested from the CENTER.

Once these two conditions are met, the CENTER will issue an invitation letter indicating the following:

- The price and the hours contracted for the course.
- The duration dates and the total number of hours of the contracted course.
- The holiday period during the training stay.
- The address of the accommodation, whether it belongs to the CENTER or not.
- If the STUDENT wishes to receive the invitation letter by postal mail, the shipping costs must be paid in advance.

#### 2. Commitments of THE CENTER and THE STUDENT.

To obtain the certificate of attendance and achievement, the STUDENT commits to attending 100% of the classroom hours of the Spanish course they have enrolled in, within the dates indicated in the invitation letter, as these classes cannot be postponed to other periods under any circumstances.

The CENTER keeps daily attendance records and will notify in writing when the STUDENT, for any reason, does not attend class. After the third unexcused absence, the CENTER is obliged to inform the consular authorities and Immigration in the event of unexcused absences by the STUDENT. This communication to the authorities may result in the revocation of the stay permit.





The CENTER is not responsible for the possible rejection of the visa or if the STUDENT does not obtain the visa on time. Therefore, The STUDENT is advised to apply for the visa well in advance. Any changes made after the reservation will incur a surcharge of €80 (for example, if the STUDENT did not apply for the visa on time and needs to postpone the course).

The CENTER will not make any refund to the STUDENT who has requested and obtained an invitation letter that can be used for the renewal of a student visa or NIE, except in the case of visa or NIE rejection. In such cases, all amounts paid will be refunded, except for an administrative fee of €80 to cover the cost of the return transfer. The refund will be made upon presentation of an official rejection letter from the Consulate or Immigration Office clearly stating the student's name, passport number, and type of visa/renewal requested (duly dated, signed, and stamped). No refunds will be granted for classes already taken, if any.

In the event that the STUDENT is denied the visa, the CENTER will charge €100 for administrative expenses. If the student made a reservation exceeding that amount, the CENTER will refund the difference. To obtain the refund, the STUDENT must send an official visa rejection document from the embassy or Spanish consular service in their country. Without this document, no refund will be made.
